

Codes for Insurance Reimbursement

Please find your appointment type below under the provider you see. We invite you to call your insurer with these codes. Let them know that you are going to see an out-of-network provider and ask how much you will be reimbursed for the code(s) that correspond with your appointment. Package patients use the same codes.

Important notes:

- Medicare and Medicaid (also called Mind Body Spirit) patients are "non-covered" with PIM
 according to Medicare. Medicare patients cannot legally submit to your secondary insurance for
 reimbursement because PIM's services are not covered by Medicare.
- For telemedicine appointments, the modifier 95 is added to your appointment codes.
